## Subject: Issued Penalties and Follow-Up to Initial Penalties

Dear Scott & Jake.

This correspondence is not written lightly, but it is necessary given the repeated nature of your actions and the events of **Saturday, August 23, 2025** at Holland Speedway.

These were not isolated incidents. Similar behavior occurred following the same event on **August 24, 2024**, and at two other Race of Champions events earlier this season. Previous verbal warnings and requirements were issued, yet the conduct has continued.

At the driver's meeting on August 23, Race of Champions officials clearly stated:

"Do not put us in a situation where we have to react to your actions."

Unfortunately, that directive was ignored.

The post-race actions, both on and off the track, were not only uncalled for but were particularly inappropriate on a night meant to honor your parent. Such behavior is unacceptable at any time, and especially at an event of significance.

#### **Conditions for Reinstatement**

If you wish to pursue a return to Race of Champions competition, the following condition must be met in full:

• **Public Apology**: A written apology, approved by Race of Champions management, must be submitted to the Series and posted publicly on social media platforms (Facebook, X, Instagram, etc.).

Until this requirement has been completed to the satisfaction of Race of Champions management, **no further correspondence, consideration, or discussion will take place.** 

# **Conduct During Suspension**

Any additional actions — including threatening, demeaning, or damaging comments made in person, electronically (via text, email, or social media), or otherwise — will be taken into account in determining the duration of your suspension. Such actions will be considered **tortious interference** with the business of the Race of Champions and damaging to the sport of short track racing. **Further legal action may be pursued.** 

### **Suspension Terms**

Effective immediately, you are prohibited from attending or participating in any Race of Champions event in any capacity, including but not limited to:

- Pit area access
- Grandstand attendance
- Any Race of Champions-controlled, sanctioned, or supported property or event

Any violation of this restriction will be treated as **criminal trespass** and handled accordingly. This suspension is **not subject to appeal or third-party mediation.** 

### **Right to Refuse Service**

The Race of Champions Modified Series reserves the absolute right to deny entry, suspend, or revoke access to any individual failing to comply with Series rules, regulations, or penalties. This right is final, binding, and exercised without exception or liability.
